

## Guidelines

### „Environmental Protection at the NÜRBURGRING“

Nürburgring 1927 GmbH &Co. KG

#### **General Organisation**

Special case must be exercised in the handling of materials which are hazardous to water (oil, fuel etc.). Any leakage and any other environmental hazard must immediately be reported to the Nürburgring 1927 GmbH &Co. KG in the start/finish building.

The organiser shall instruct the marshals and all other responsible persons to absorb leaked oil or fuels with oil binding agent and to dispose those in the red containers provided for used oil.

The pits hired by the organiser shall be returned clean swept and any carpets possibly installed shall be completely removed from the pits after the event.  
Any adhesive tapes used for the attachment of the floor covering must not damage the paint on the pit floor and must also be completely removed after the event.

#### **Waste avoidance / waste disposal**

The dispensing systems for drinks (no sale) (“Hospitality”) shall as far as possible be multiple-use systems (beakers or crockery). Disposable beakers and cans should not be issued. Disposable crockery or low-waste package shall also be used for food.

Waste disposal will generally be effected by the Nürburgring 1927 GmbH &Co. KG. It is not permitted to charge a third-party contractor with the waste disposal on the premises of the Nürburgring.

#### **Waste collection shall be separated according to the following categories:**

- **Package/recyclable materials (yellow containers)**
- **Glass (glass container and green containers)**
- **Paper, paperboard, cardboard (blue lattice box)**
- **Food garbage (brown container)**
- **Residual rubbish without recyclable substances (grey container)**
- **Used oil in event-related quantities (used oil depot)**
- **Oil containing solid matters in event-related quantities (used oil depot).**

Hazardous waste with the exclusion of used oil and oil containing solid matters (oil filters, cleaning rags) shall not be disposed through the Nürburgring 1927 GmbH &Co. KG but must be disposed after the event by the waste producer. This includes in particular batteries, brake fluids, cold cleaners and radiator coolants.

Any catering or hospitality operators must dispose their rubbish at their own expenses. The necessary containers must be ordered from the Nürburgring 1927 GmbH & Co. KG, E-Mail: [FM@nuerburgring.de](mailto:FM@nuerburgring.de) (Fax: 02691 / 302-9199) until 5 days before the event at the latest.

Rubbish containers and their attachment devices must not be removed from their position. Any waiver is subject to the approval of the Nürburgring 1927 GmbH & Co. KG.

### ***Soil protection***

The organiser must ensure that any pollution of the ground through any matters harmful to the environment such as oil or fuels is avoided. In the handling of such matters, catch tanks or foils must be used and special care must be exercised. Oil absorbing matters must be on stand-by and any contaminated absorbing matters must be disposed in the “red used oil depot” in the designated containers as hazardous waste.

### ***Wastewater disposal***

There is a separate disposal for surface water and for wastewater at the Nürburgring:

- Sanitary wastewater and kitchen wastewater must be discharged into the wastewater inlets that are marked green or into mobile tanks.
- Surface water inlets are marked red and may **not** be used to discharge **wastewater**.

The organiser shall bear the costs for necessary connecting pipes to the wastewater inlets or for the installation of mobile wastewater tanks in areas where no sewer system is available.

Materials hazardous to the environment such as fuels, oil or cold cleaners may not be discharged into the sewer system.

### ***Energy and water saving***

Electricity and water must be used as economically as possible. The heating and ventilation of buildings must be applied according to actual individual needs. Unneeded energy sources (switches in stand-by mode, lighting, power units etc.) must be switched off. Cleaning of cars must be limited as far as possible.
