The following changes and addition apply with immediate effect

(Changes/ additions are shown in *italics*)

The following VAT adjustments have become necessary due to the economic stimulus package adopted by the German government.

Chapter I Sporting Regulations

10. Entry fee, other fees and charges will be change as follows:

10.3 Entry fees - refund will be change as follows:

- Of a justified withdrawal of the entry less than 6 weeks before the final entry closing date, after deduction of an administration fee of 300,00 Euro incl. 19 % VAT.
- Of the withdrawal of the entry due to amalgamation of classes more than 7 days after the posting of the entry confirmation, after deduction of an administration fee of 300,00 Euro incl. 19 % VAT.

Furthermore, you may in addition purchase the maximum of 5 tickets "Pit" and 5 tickets "TOTAL-Lane" at a special price of 25 Euro, 16% VAT included, (valid from Thursday to Sunday in the paddocks, on all open grandstands and in the pits).

The use of a quad is subject to the purchase of a corresponding pass at the price of 200,00 Euro incl. 16 % VAT. This pass must be solidly fixed to the vehicle. Any quad parked on the paddock roads or on the safety roads will always be towed away by the organiser at the owner's costs. Quads failing to display the corresponding pass will also be towed away at the owner's costs.

There is a possibility for suppliers to be provided with a short-term supplier vehicle pass (spare parts, catering etc.) upon a deposit of 200,00 Euro incl. 16 % VAT.

12. Paddock Organisation will be change as follows:

12.13

Illegally parked vehicles or vehicles failing to display the correct identification will be towed away at the owner's costs. A flat rate of 300 Euro incl. 16% VAT will become due and payable for the first towing operation. Furthermore, the crossing pass will then be collected. The car will only be released by the chief paddock marshal upon payment of this fee. Should a vehicle have to be towed away a second time, a fee of 600 Euro incl. 16 % VAT, will become due and payable.
